Definitions

When we talk about 'us', we mean OurEcoClean. When we talk about 'you', we mean you as a user of this website or purchaser of our products. Our contact details are in the schedule at the end of this policy.

'Personal data' or 'personal information' is information that directly identifies you, such as your name and email address, or data that could be used, on its own or in combination with other data, to identify you.

We aim for compliance with Australian Privacy Law and the General Data Protection Regulations (GDPR).

Under the GDPR, we are a data controller when it comes to your personal information.

Staying Anonymous

You can browse our website anonymously, although cookies may be collected. You will not be able to access our services anonymously. Once you access our services, including for example by joining our mailing list or making a purchase, we will begin collecting your personal information in accordance with this policy.



Collection and Use of Data

We collect personal data about you when you give it to us for an agreed purpose. This generally occurs when you purchase a product, 'Like' or follow our social media pages, request information from us, or subscribe to our mailing list.

We may use your personal information to contact you about your purchase and products you have enquired about, to keep you up-to-date with our activities, or to save your shipping information for the next time you purchase from our website.

Other than as disclosed in this privacy policy. We never sell, rent or otherwise disclose your personal information to third parties.

We collect and process the minimum amount of information required to deliver our products to you. We process this information to fulfill your order. This information includes:

- your first and last name
- the postal address supplied by you
- your phone number (only if supplied by you)
- your email address
- payment details
- any other information you supply to us

When you purchase through our website, we will also store your IP address. We process this information for our legitimate business purpose of matching your IP address with your user information. Unless stated otherwise in this policy, personal information will be held for our business purposes for a period of up to seven years. After that time, we may still retain your personal information however if we do so, it will be in a form where personal details are de-identified. This means once the data is made anonymous and you will not be able to be identified.

With your permission, we may use your email address to send you emails about our activities. These emails may contain links to other information. We process this information based on your consent. You may always withdraw your consent and unsubscribe from these emails by clicking on the unsubscribe link at the bottom of the email or by contacting us using the information set out above.

If you interact with us on social media sites (eg. Facebook, Instagram, Twitter, LinkedIn, YouTube, Pinterest), we may receive information about you. We may process this data as a legitimate business interest to properly administer our business and website and communications with users. You should be aware that personal information you disclose on social media sites is publicly available.

We may also receive information through third party sites like WordPress or Salesforce.

We accept payments using PayPal and National Australia Bank on-line payment services. We may also make available payment systems like Zip and Afterpay. Those payment services provide us with the online ecommerce platform that allows us to sell our products and services to you. We do not take custody of or store your card details, although our payment processors may store that information on our behalf. We may also use Xero to send invoices to you.

California Do Not Track Disclosure

Data Rights

You have the right to ensure -

- We process your data fairly and lawfully and within the purpose and/or consent it was provided to us.
- Your data is accurate.
- The data collected by us is not excessive.

To ensure this happens, you can -

- have your data updated and amended if incorrect, out of date or incomplete.
- restrict the level of processing or automated processing we do.
- know how long we keep your data.
- ask us to erase your data and be forgotten.
- ask us to provide details of the personal data we hold.

To achieve this, at your request, and upon production of satisfactory identification, we will tell you what personal data about you is being processed (eg. what information we have stored), on what basis, and by whom.

You may amend inaccurate, incomplete or outdated personal data at any time by applying directly to us using the contact information in the schedule below.

If you decide your data should not be processed for one or more purposes, you may withdraw your consent from using your data in that way. Please note that we will action your request as soon as practically possible however such a request will not take effect immediately and your data may still be used in the meantime.

You may request that all personal data we have collected about you be deleted from our records and erased from information stored by any third party organisations processing data on our behalf.

If data we have collected about you is processed using automated means, you have the right to receive that data in a structured, machine-readable format and to transmit it to another data controller without hindrance.

If you make a request to be forgotten:

- your personal information may not be removed from our back-ups as we are unable to remove specific files from our backup,
- comments you have made in public areas may not be able to be removed (or may be made anonymous if possible),
- video footage may be deidentified rather than being removed (eg. your image may be blurred and identifiable information removed).

Cookie Policy

Our Cookie Policy provides information about the cookies we use.

What is a cookie?

A "cookie" is a piece of information that is stored on your computer's hard drive and which records how you move your way around a website so that, when you revisit that website, it can present tailored options based on the information stored about your last visit. Cookies can also be used to analyse traffic and for advertising and marketing purposes.

Cookies are used by nearly all websites and do not harm your system.

If you want to check or change what types of cookies you accept, this can usually be altered within your browser settings. You can block cookies at any time by activating the setting on your browser that allows you to refuse the setting of all or some cookies. By not blocking cookies and continuing to browse you are authorising the use of cookies. If you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of our site.

How do we use cookies?

We use cookies to track your use of our website and to enable some functions of our website to work properly. This enables us to understand how you use the site and track any patterns with regards how you are using our website. This helps us to develop and improve our website as well as products and / or services in response to what you might need or want.

Cookies are either:

- Session cookies: these are only stored on your computer during your web session and are automatically
 deleted when you close your browser they usually store an anonymous session ID allowing you to browse a
 website without having to log in to each page but they do not collect any personal data from your computer;
 or
- Persistent cookies: a persistent cookie is stored as a file on your computer and it remains there when you close your web browser. The cookie can be read by the website that created it when you visit that website again. We use persistent cookies for Google Analytics.

Cookies can also be categorised as follows:

- Strictly necessary cookies: These cookies are essential to enable you to use the website effectively, such as when buying a product and / or service, and therefore cannot be turned off. Without these cookies, the services available to you on our website cannot be provided. These cookies do not gather information about you that could be used for marketing or remembering where you have been on the internet.
- Performance cookies: These cookies enable us to monitor and improve the performance of our website. For example, they allow us to count visits, identify traffic sources and see which parts of the site are most popular.
- Functionality cookies: These cookies allow our website to remember choices you make and provide enhanced features. For instance, we may be able to provide you with news or updates relevant to the services you use. They may also be used to provide services you have requested such as viewing a video or commenting on a blog. The information these cookies collect is usually anonymised.



Please note that third parties who advertise on our website (including, for example, advertising networks and providers of external services like web traffic analysis services, if any) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

Specifically:

- If you make a purchase on our website you may opt-in to saving your name, email address and delivery address using our cookies. These are for your convenience so that you do not have to fill in your details again when you make another purchase. These cookies will last for one year.
- If you create an account and visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.
- When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.
